## RELEASE, ASSUMPTION OF RISK and INDEMNITY AGREEMENT

I, the undersigned, acknowledge, appreciate and agree that there are significant elements of risk in any adventure, activity or sport associated with water and the outdoors. I have read (on the back of this form) and am fully aware of the risks, hazards and dangers inherent in whitewater activities.

I certify that I am fully capable of participating in the said activity. I further understand that A Helfrich Outfitter LLC reserves the right to refuse any person it judges to be incapable of meeting the rigors and requirements of participating in a rafting trip.

Therefore, I assume full responsibility for personal injury to myself and/or to members of my family and for loss or damage to my personal property and expenses thereof as a result of my negligence or the negligence of my family while participating in said activity, except to the extent that such damage or injury may be due to the negligence of A Helfrich Outfitter LLC.

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, indemnify and hold harmless A Helfrich Outfitter LLC, its officers, officials, agents and/or employees, other participants, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event (releasees) from any and all claims, demands, losses and liability arising out of or related to any injury, disability or death I may suffer, or loss or damage to person or property, whether arising from the negligence of the releasees or otherwise, to the fullest extent of the law.

The venue of any dispute that may arise out of this agreement or otherwise between the parties to which A Helfrich Outfitter LLC or its agents is a party shall be either the City of Springfield Oregon, Oregon Justice Court or the County of State Supreme Court in Lane County Oregon.

Significant elements of risk and dangers are associated with any adventure, activity or sport associated with water and the outdoors. They include, but are not limited to, the following.

- Hazards of traveling on a raft in normal, rough or flooded river conditions
- Hazards of jumping, diving or being thrown into unfamiliar water with submerged hazards, undercut rocks and man-made hazards
- Hazards of rafts flipping or dumping guests
- Hazards of long, cold swims
- Hazards of being pinned under and/or against trees, rocks, rafts or other objects
- Contact with oars, paddles, helmets, other guests or guides, or other pieces of equipment
- Diseases from contaminated water and/or water-borne amoebas
- Allergies
- Disease
- Strains or sprains
- Fractures or punctures
- Partial and/or total paralysis
- Loss of or damage to personal property
- Insect bites or stings
- Illnesses or injury in relatively remote places without medical facilities
- Failure or lack of communication equipment
- Failure or lack of safety equipment
- Injuries occurring in rescue operations
- Falls from elevated features
- Hazards entering and leaving raft
- Hazards of loading or unloading people or items from vehicles
- Hazards from forces of nature
- Falling limbs or trees
- Problems or hazards related to travel by conveyance (vehicle accidents)
- Death
- Accidents

- Entrapment
- Slippery surfaces
